Below are questions/*answers* for the above referenced RFQ. All other terms and conditions remain the same.

- 1) Will smoke detectors be required for the new A/C units?  
*Smoke detectors are not required.*
- 2) Will the duct detectors be tied into the existing Fire Alarm System? If so will the panel need new battery calcs to handle the new load?  
*Not needed*
- 3) Will there be any smoke dampers required in the A/C units?  
*No. Smoke dampers are required in the air distributions systems shown for this project.*
- 4) Will Panel A/C be located on the roof of the north gym or on the south exterior wall/roof of the lower roof? Will the feeders need to be derated running across the roof due to the heat from the sun. Is there an alternate location this panel can be installed and have A/C feeders run inside the building and stub thru the roof at the unit locations?  
*Yes, panel will be located on lower roof not the upper roof. All feeders have been derated for outdoor. There is no alternate location and we did not want multiple penetrations thru roof.*
